director of the Trail Conference, a non-profit federation of hiking clubs and environmental organizations dedicated to building and maintaining hiking trails and protecting related open space, said the 19th century building's character would not be compromised.

The building, which sits on 2.8 acres and is about 4,744 square feet, will serve as the Trail Conference's headquarters, currently located at 156 Ramapo Valley Road in Mahwah, with offices, meeting rooms and public exhibits.

"The structure's interior will be adaptively reused to provide for the execution of our day-to-day operations," Goodell said. "Our greatest challenge will be making it as green as possible while not sacrificing historical integrity."

Goodell said requests for architectural proposals would be released sometime this month. Fund raising will begin immediately, and he said he hopes construction may begin in the spring. Additional renovation funds are being sought from the Mahwah community and corporate sources.

"Based on donations and the generosity of our neighbors, I hope to complete a first-class rehabilitation of the schoolhouse," Goodell said.

Local historian Carol Greene, a member of the schoolhouse steering committee, said the purchase of the schoolhouse has been an uphill struggle.
